**Step 1: Complete Team Registration Form Page 2 for ALL EVENTS.** Make sure you list a working email address as your confirmation packet will be emailed to you. If possible, please list two email addresses. **You can complete one per gym/organization.**

**Step 2: Complete Team Registration Form Page 3 for Opens/Classics; Page 4 for Nationals; Page 5 for FINALE.**

**Step 3: Complete a Team/Medical Roster Form – Page 6/7.** We need 1 Team Roster Form for **EACH** team participating.

\*Coaches can choose between a team medical roster for the entire team or one waiver per participant option\*

**Step 4: Complete/Collect a medical waiver for each participant and each coach if you did not use the Team Medical Waiver Form.** This form is valid for any event you attend September 1, 2018 through August 31, 2019. If sending in Individual Medical Waivers, please put in alphabetical order along with the team roster on top when mailing in. **Medical Waivers are due 10 days prior to the event!** CDE uses the IEP Universal Waiver Form located on our website under COMPETITIONS -> FORMS.

**Step 5: PAYMENT – Page 8.** If you are paying via **Credit Card**, please complete a credit card authorization form. CDE accepts Visa, MasterCard, Discover, and American Express. A 3% convenience fee will be issued for utilizing this method. If paying with **check/money order**, checks are due in the office **10 days prior to the event.** After this time, Money Order or Bank Certified Check is the only method accepted.

**Step 6:** Place your Team Registration Forms (Page 2 and Page 3-5), Payment (Page 8), Team Rosters/Medical Waivers (Pages 6-7) in an envelope and mail it to us at the address listed above in the Mailing Address Box or Fax to us at the number listed in the Contact Us box above. **Please do not fax the individual medical waivers!**

**Once your registration has been received:**

1. You will receive a confirmation email from us within 48 hours of receiving your registration. If any registration documents are due we will alert you at this time.
2. If you are cleared for registration, seven days prior to the competition you will receive a tentative order of performance. If your team is listed in the incorrect division, you have 24 hours from the time this is sent to alert Cheer and Dance Extreme. If you change your division after this time, then a division change fee will be assessed.
3. The Monday prior to all competitions, CDE will release a preliminary schedule of performance on our website. This can be found by selecting "Competitions" and scrolling to the event that you are registered for.
4. The Thursday prior to all competitions, an updated Order of Performance will be released on our website. The final schedule will be distributed to coaches at Check-In the day of the event.

**The day of the event:**

1. If you have failed to submit any documents or you have last minute medical waivers, please bring them with you. CDE strongly encourages coaches to submit medical waivers prior to the event. One coach needs to check in your team at the Team Check In area. All coaches will need to check themselves in to receive their credentials and pick up a final order of performance. All score sheets will be distributed at the awards ceremony or immediately after the ceremony at all CDE events. If you have any questions at that time about your scores or penalties, CDE's head judge will be available to assist you.

In consideration for participation in competitions and/or other events that Cheer and Dance Extreme and/or any of their respective subsidiaries, affiliates, successors and/or assigns, sponsors, administers, manages, provides instruction for or is otherwise involved with in any manner, directly or indirectly, at any time during the calendar year September 1, 2018-August 31, 2019 and the use of the property, facilities, services and instruction of Cheer and Dance Extreme, today, and on all future days (the "Additional Services") (the competitions and the additional services are collectively referred to herein as the "Activities"), the participant, his or her parent or guardian, and all of their heirs, assigns and personal representatives (collectively the "Participant"), hereby agree to the following:

1. The Participant understands that as in all athletic endeavors there are risks in and around the activities including, but not limited to, injury, sickness, and in some cases death. The Participant agrees to assume any and all risks arising out of or related to the Activities, including, without limitation, the risks of physical injury, emotional injury, sickness, death, property damage, falls, collisions with people or stationary objects, the unavailability of emergency medical care, and/or the negligence and/or deliberate act of another person.
2. The Participant authorizes Cheer and Dance Extreme to transport or authorize transportation of the Participant to a medical facility and/or hospital and for Cheer and Dance Extreme to authorize emergency medical treatment to the Participant.
3. 6. This Agreement shall be enforced and interpreted under the laws of the State of Maryland (except Maryland's conflict of laws principles). Should any clause or any part of any clause be determined to be illegal or unenforceable by a court, administrative body or arbitrator of competent jurisdiction, such clause shall be amended to the smallest degree necessary to render such clause valid and enforceable and the remainder of this Agreement shall not be affected. When Participant's parent or guardian, if Participant is a minor, signs the Agreement, the term "Participant" as used throughout this Agreement will be deemed to include, without limitation: (1) the Participant; and (2) the Participant's parent or guardian; and (3) all of their respective heirs, assigns, and personal representatives.
